THE PROMOTION

1. The Promoter is Samsung Electronics (UK) Ltd, of Samsung House, 1000 Hillswood Drive, Chertsey, Surrey, KT16 0PS. (“the Promoter” or “Samsung”. Please do not send any free installation applications to this address - they will not be registered for the installation promotion.
2. This promotion entitles participants who purchase any of the devices listed in paragraph 3 below between 1 October 2018 and 31 March 2019 to claim a free of charge installation through a Samsung Accredited installation partner.
3. This promotion only applies to all participants who purchase any of the following models of new (not secondhand) LED screens listed below, which are purchased in the UK (the “Product”):

ELIGIBILITY

1. To be eligible to participate in the Promotion you must be a business customer based in the UK. This Promotion is not applicable to consumers.
2. Employees or agents of the Promoter or their families or households or anyone professionally connected to this Promotion and any group company of the Promoter are not eligible to enter.
3. This Promotion is limited to one installation per purchase of related modules and components comprising a single LED display.

REDEMPTION PROCESS & DETAILS

1. This promotion cannot be used in conjunction with any other promotion(s) or special bid/tender pricing offered by Samsung.
2. To activate the installation promotion, participant must email led.service@samsung.com with proof of purchase.
3. Samsung will provide the participant with T&Cs and installation request documentation which is to be returned to led.service@samsung.com.
4. Upon receipt of completed documentation from the participant and verification of the proof of purchase by Samsung, Samsung will schedule installation works with a Samsung approved installation partner. Participants must give a minimum of 21 days’ notice to Samsung for installation scheduling.
5. If inaccurate information is provided by the participant as part of the installation request documentation, the participant will be liable for any additional associated costs incurred as part of the installation.
6. The Samsung approved installation partner will attend the site on the agreed date to complete the installation, subject to these Terms and Conditions.
7. The warranty for the Product will be activated upon sign off of the installation providing installation has been carried out by Samsung’s approved installation partner within 90 days of purchase.

INSTALLATION TERMS

1. The participant or its partner representatives must be on site for installation.
2. The participant shall ensure that while Samsung or its authorised installation partner are on the premises it shall comply with all applicable laws and regulations, including but not limited to health and safety laws.
3. The participant will provide a suitable mounting surface in accordance with the manufacturing guidelines issued by Samsung. The mounting surface must be flat, level, perpendicular and of sufficient size and structural strength to hold the specified display loading.
4. If the participant requires Samsung to mount the LED screen within an aperture or enclosure there should be sufficient space around the display to allow adequate ventilation as stated in the IF ventilation guide.
5. The participant will provide one 13A fused socket for every 3 LED cabinets to be installed to the rear of the LED mounting surface.
6. The participant will ensure that there is a cable route with drawstring for a category 6 Ethernet cable to be pulled from the display controller to the bottom left corner of the display area.
7. The participant will ensure that there is a location with one 13A mains socket for the display controller to be mounted within 5 metres of the bottom left corner of the display area.
8. The participant will provide the equipment needed to display content on the LED screen
9. Providing conditions 1-9 above are in place, Samsung will carry out installation of the LED sections and will mount a Samsung approved mounting frame.

GENERAL TERMS OF PROMOTION

1. These terms and conditions are governed by English law and the English courts shall have exclusive jurisdiction to settle and resolve any dispute which may arise in connection with the validity, effect, interpretation and/or performance of these terms.
2. By registering for the free of charge installation you agree to be bound by these terms and conditions.
3. The Promoter shall have the right, where necessary, to undertake all such action as is reasonable to protect itself against fraudulent or invalid claim(s) including, without limitation, to require further verification as to the identity, and other relevant details of an entrant or claimant and/or the verification as to their qualifying purchase.
4. The Promoter’s total liability to the Participant shall not exceed £10,000. The Promoter’s total liability includes liability in contract, tort (including negligence), breach of statutory duty, or otherwise, arising under or in connection with the Promotion and any installation services carried out as part of the Promotion.
